#### Description

The Tarlac State University, through Special Budget (SB) 2025 intends to apply the sum of Two Million Nine Hundred Ninety-Nine Thousand Six Hundred Forty-Five and 07/100 Pesos (₱ 2,999,645.07) to payments under the contract for the project: Refurbishment of College of Engineering Student Center. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Tarlac State University now invites bids for the aforementioned Project. Completion of the Works is required within one hundred fifty (150) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non- discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Failure of bidders to comply with the said request of additional copies shall not be a ground for disqualification.
