**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Rice with an Approved Budget for the Contract (ABC) of ₱ 2,123,500.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on March 18, 2024;

**WHEREAS**, in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on March 26, 2024;

**WHEREAS**, in the public bidding held at the TSU-BC AVR on April 11, 2024, at 3:00 P.M.:

- (a) two bidders, namely, Cresto Trading Corporation, and Maunlad Rice Corporation, tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bid submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Cresto Trading Corporation contained all the required documents and was rated "passed", while Maunlad Rice Corporation was found to be "ineligible" on the ground that its Class "A" document uploaded in the PhilGEPS was not current and updated;
- (c) the BAC with the assistance of the TWGs, then opened and checked the second envelope contained in the bid of the lone bidder and found that the second envelope contained the prescribed documents and was rated "passed";
- (d) the BAC resolved to declare Cresto Trading Corporation, as the bidder with the Single Calculated Bid with the amount of 1,972,800.00,
- (e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the and Single Calculated Bid;

**WHEREAS**, in the Post-Qualification Evaluation Conference held via Zoom on April 26, 2024:

- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents,

- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive;

**THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare Cresto Trading Corporation, as the bidder with the Single Calculated and Responsive Bid (SCRB), with the bid price of One Million Nine Hundred Seventy Two Thousand Eight Hundred Pesos (1,972,800.00), and
- (b) to recommend to the President the Award of Contract for the project, Supply and Delivery of Rice to Cresto Trading Corporation.





**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Rice with an Approved Budget for the Contract (ABC) of ₱ 2,123,500.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on March 18, 2024;

**WHEREAS**, in response to the Invitation to Bid, two (2) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on March 26, 2024;

**WHEREAS**, in the public bidding held at the TSU-BC AVR on April 11, 2024, at 3:00 P.M., two (2) bidders, namely, Cresto Trading Corporation, and Maunlad Rice Corporation participated and tendered a bid for the aforementioned project,

**WHEREAS**, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bid submitted by the two bidders, using the non-discretionary “pass/fail” criterion, and found that the first envelope of Cresto Trading Corporation contained all the required documents and was rated “passed”, while Maunlad Rice Corporation was found to be “ineligible” on the ground that its Class “A” document specifically the audited financial statement submitted to PhilGEPS was not current and updated;

**WHEREAS**, the BAC with the assistance of the TWGs, then opened and checked the second envelope contained in the bid of Cresto Trading Corporation and found its second envelope contained the prescribed documents and was rated “passed”;

**WHEREAS**, the BAC with the assistance of the TWGs, then evaluated the financial bid of the lone bidder with the result as summarized below:

**THEREFORE**, based on the foregoing findings, WE, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (b) to direct the Technical Working Groups to proceed with the Post-Qualification Evaluation of the SCB and report their findings to the BAC within the prescribed period, and
