

**CONTRACT AGREEMENT**

THIS AGREEMENT made this JAN 11 2024 day of 2024, 2024 between **TARLAC STATE UNIVERSITY of Romulo Boulevard, San Vicente, Tarlac City** (hereinafter called the "Entity") and **R.M. MANGUBAT CONSTRUCTION of G/F Block 1, Lot 6 Dona Manuela Avenue, Dona Manuela Subd. Pamplona III, Las Piñas City** (hereinafter called the "Contractor").

WHEREAS the Entity is desirous that the Contractor execute **Construction of TSU Warehouse** (hereinafter called "the Works") and the Entity has accepted the Bid for **Twenty-Five Million Seven Hundred Thirty-Four Thousand Nine Hundred Thirty-Six Pesos and Twenty-Two Centavos (Php 25,734,936.22)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. Philippine Bidding Documents (PBDs);
    - i. Drawings/Plans;
    - ii. Specifications;
    - iii. Bill of Quantities;
    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - c. Performance Security;
  - d. Notice of Award of Contract and the Bidder's conforme thereto; and
  - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Twenty-Five Million Seven Hundred Thirty-Four Thousand Nine Hundred Thirty-Six Pesos and Twenty-Two Centavos (Php 25,734,936.22)** or such other sums as may be ascertained, **R.M. MANGUBAT CONSTRUCTION** agrees with the project: **Construction of TSU Warehouse** in accordance with his/her/its Bid.

4. The Tarlac State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. This Agreement shall take effect upon date of confirmation of **NOTICE TO PROCEED** by the Contractor from the Entity. The Contract shall remain in force until all obligations of both parties as contained in this contract have been fully complied with
6. The Contractor shall commence execution of the project within ten (10) calendar days from the confirmation of written Notice to Proceed from the Entity and shall finish and complete the construction of the project within **Two Hundred Seventy (270) calendar days** from the date of confirmation unless extended in accordance with the IRR of R.A. 9184.
