FOR THE COLLEGE OF TEACHER EDUCATION (APP 2022)"**

**APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 2,462,696.00**

**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Furniture and Fixtures for the College of Teacher Education (APP 2022) with an Approved Budget for the Contract (ABC) of ₱ 2,462,696.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on February 16, 2022;

**WHEREAS**, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on February 23, 2022;

**WHEREAS**, in the public bidding held at the TSU-BC AVR and webcasted via Zoom on March 8, 2022, at 3:00 P.M.:

- (a) three (3) bidders, namely, Asahi Design Centre Inc., ACMI Office System Phils. Inc., and Roseco Mktg. Ventures, tendered bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bids of the three bidders and found the bids to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and were rated "passed",
- (c) the BAC resolved to declare Asahi Design Centre Inc., as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 1,836,500.00, and
- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

**WHEREAS**, in the Post-Qualification Evaluation Conference held via Zoom on April 13, 2022:

- (a) the TWG for the Financial and Legal Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for the Technical Aspect reported that the LCB was non-responsive for failing to comply to the technical specifications,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as non-responsive,

- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of ACMI Office System Phils., Inc., the second Lowest Calculated Bid, and
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to Asahi Design Centre Inc.;

**WHEREAS**, the Notice of Disqualification was transmitted to Asahi Design Centre Inc., on April 29, 2022;

**WHEREAS**, the BAC received a Request for Reconsideration from Asahi Design Centre Inc., on the same day, April 29<sup>th</sup>, 2022;

**WHEREAS**, the BAC immediately relayed the Request for Reconsideration of Asahi Design Centre Inc., to the TWG for the Technical Aspect for their appraisal;

**WHEREAS**, in the BAC Meeting held via Zoom on May 10, 2022:

- (a) the TWG for the Technical Aspect reported that of Asahi Design Centre Inc. was able to prove that they complied with the technical specifications for the project in the arguments and explanations that were presented in their Request for Reconsideration,
- (b) the TWG for the Technical Aspect attested that based on the merit of their Request for Reconsideration, the bid of Asahi Design Center Inc. is found to be responsive, and
- (c) the BAC deliberated on the report and attestation of the TWG for the Technical Aspect and unanimously agreed to reverse their earlier decision declaring the LCB as non-responsive to responsive

**THEREFORE**, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Asahi Design Centre Inc., as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 1,836,500.00 and
- (b) to recommend to the President the Award of Contract for the project Supply & Delivery of Furniture and Fixtures for the College of Teacher Education to Asahi Design Centre Inc.
